Second Schedule - Trustee Elections

2. ELIGIBILITY FOR APPOINTMENT

Nominee to be registered

- 2.1 Subject to *rule 2.2* of this Schedule, a person is eligible to be a Trustee if he or she is:
 - (a) aged eighteen years of age; and
 - (b) a Registered Member; and
 - (c) resident in New Zealand.
- 2.2 A person is not eligible to be a Trustee if he or she:
 - (a) does not meet the requirements of rule 2.1 of this Schedule;
 - (b) is bankrupt and or has within the last (5) years been adjudged bankrupt;
 - (c) is or has ever been convicted of:
 - (i) an offence involving dishonesty as defined in section 2(1) of the Crimes Act 1961; or
 - (ii) an offence under section 373(4) of the Companies Act 1993, unless that person is an eligible individual for the purposes of the Criminal Records (Clean Slate) Act 2004;
 - (d) is or has ever been disqualified from being a director of a company registered under the Companies Act 1955 or the Companies Act 1993;
 - (e) is or has ever been removed as a trustee of a trust by order of a Court on the grounds on breach of trust, lack of competence or failure to carry out the duties of a trustee satisfactorily;
 - (f) becomes subject to a compulsory treatment order the Mental Health (Compulsory Assessment and Treatment) Act 1992; or
 - (g) becomes subject to a property order made under section 30 or section 31 of the Protection of Personal and Property Rights Act 1988; or
 - (h) has within the last three (3) years been removed from the office of Trustee in accordance with clause 24 of this Deed or rule 12 of this Schedule.

Candidate statement (a maximum of 250 words): Must be confined to information concerning the candidate, and the candidate's policies and intentions if elected.

Text must be plain black text, but special formatting (macrons, bold, italics, underlining, quote marks,) is permitted.

Photo

Must include a recent (i.e. less than one year old) photograph of the candidate only (i.e. not part of a group). Photos may be in an electronic, format (scanned as a jpeg attachment on email), or hard copy. Photos will be printed in black and white only but can be supplied in colour. (N.B. photos will not be returned to candidates)

The Returning Officer reserves the right to:

- Collate information to be included in voting material to be forwarded to lwi registered members, if an election is required.
